

City Administrator Report to Mayor & City Council

WEEKLY UPDATE:

- Budget: Reminder - Our first budget meeting is in less than two weeks on January 28th at 5:30PM in Council Chambers. This is a short meeting in which we will provide a summary of the General Fund Budget.
- Bi-State: Attached is the January 2016 Commission Packet for Wednesday, January 27, 2016 meeting. Phones:
- Property: As requested, our City Planner has prepared the attached spreadsheet which includes property obtainable from back taxes and city owned parcels.
- Colorado Street: Attached is a photo of the new solar powered trail crossing signs and pedestrian signal that was recently installed on Colorado.
- Bowling: Rose Bowl Lanes and the Muscatine United States Bowling Association have requested that the CVB/City and the Chamber participate at the March 12th bid presentations for the Women's State Bowling Championship for Spring of 2018. This event covers multiple weekends (usually 2-3 day stays for our hotels).
- In-Depth Meeting: Upcoming items - Landfill Update, Second Street Reconfiguration, Hotel approach, drive up/drop off, and affects to Iowa, Chestnut and Mississippi Drive.
- Dogs: Attached are two "dog bite" forms provided by the Police Department. To be clear, being on this list means that a bite form was filled out, but it does not mean that a citation was issued.
- Phones: As request, here is a brief summary of City Hall phone numbers - all departments have access to our centralized phone system. Some departments do have direct lines, but have staffing available to cover the phones. Otherwise, calls may be directed to the central line or the message system.
- Startup Grind: I enjoyed being the guest speaker at Startup Grind this past Tuesday night. We had the opportunity to discuss small business, the downtown and our current programs.
- P&R: The Muscatine Parks and Recreation Department is looking for 5-10 volunteers to assist with the Winter Festival on Saturday, January 30, 2016 from 12:30-3:30 p.m. at Muscatine Municipal Golf Course. This is a free event that is open to the public from 1-5 p.m. We will need volunteers from 12:30 p.m sharp -3:30 p.m. We will meet at Muscatine Municipal Golf Course clubhouse. If you are interested in helping out please let me know before Friday, January 29. We also have opportunities to have a station at the Progressive Firepit Dinner from 3-5 p.m. If you are aware of a business that would be interested in hosting a Firepit and providing a bite size portion of a one of their dishes, please let Karen know that as well. - Health Inspections: Per request, please see the following summary of the health inspection program that was discontinued back in October as provided by Community Development Director Gobin. The City's routine inspection volume did not meet expectations of 220-230 sites per year. The Agreement's program

standards were not met (per sections of the Agreement): #2 Training was not adequate or documented, #3 Risk-based methods were not submitted, #4 Quality Assurance was not measured, #6 Compliance & Enforcement was not adequately up to date. However, the City and DIA do not agree on most of these points: The DIA's digital record system would not provide for most (i.e. pre-inspections, re-inspections) inspections to be recorded. Those that could be recorded were for new or renewal health inspections only (therefore, the numbers were skewed), the City had a significant number of follow-up inspections and violations that required monitoring...none were able to be recorded. The City dedicated one person to perform health inspections with the highest level of training in the State (documented). The DIA simply does not cross reference training with their records and would not recognize this when factoring their decision. Counter to their argument, the DIA tried to pilfer the City's agent to work for them once the Agreement was discontinued. The Health Inspector electronically submitted the risk-based methods employed for each health inspection as part of the normal inspection process, the DIA just did not review the City's records regarding this. As requested by the DIA, the department had committed to train a second inspector to be placed in service in mid-2016 as a back-up and for coverage during vacations, etc., but this was not acknowledged by the DIA during their decision. The department did have a problem with quality assurance of inspections that were done (up to 5 years ago) by an unqualified inspector that is no longer with the City. The DIA used that poor history and the back-log it created from those health inspections against the City. Although the department had made significant progress on the back-log it still had not been caught up yet. An impossible task with one inspector. According to the map of counties the DIA intended to take health inspections over, their strategy only left a few Counties or Cities in Iowa to do their own inspections. The only jurisdictions to date that remain, other than the DIA themselves, are the Cities of Des Moines, Dubuque, Council Bluffs and Shelby, Ida, Cerro Gordo, Washington, Johnson, Linn, Scott & Blackhawk Counties. It was noted during discussion with DIA that the DIA intends to expire 28-E Agreements through attrition with several of the remaining jurisdictions over the next few years. In Muscatine's case, the DIA is using one inspector to cover 3 counties (Clinton, Muscatine and Louisa), whereas, we had one specifically for Muscatine. At last count, the DIA has performed only 6 inspections since October 2015. We question how the DIA will provide the same level of service the City once provided? Fees generated (dictated by the State) did not cover 50% of the cost of the full-time health inspector. The decision to discontinue the 28-E Agreement was made by the Director of the DIA and did not allow Muscatine any appeal or due process. The 28-E Agreement was terminated on October 1st, 2015. The revenue budgeted for FY 2016 was \$33,500. Through September the city collected \$10,263.

- Symphony: Re - Special Opportunity to Host National Level Chinese Orchestra Members! The Orchestra will be in town February 23-26, 2016. Who are the guests? The Chinese Broadcasting Chinese Orchestra (CBCO) will perform in Muscatine on February 24 at 7 p.m. at Central Middle School. CBCO is a national level Chinese Orchestra that was established in 1953 as one of the five troupes of the China Broadcasting Performing Arts Troupe. As the famous brand for Chinese music and the symbol of the Chinese culture, CBCO has conveyed the connotations of Chinese history and culture through excellent performances. The

orchestra has performed in more than 70 countries and regions, making great contributions to the promotion of the Chinese culture and art. The orchestra has also produced thousands of movies, TV programs and radio programs, tapes and CDs. The performing team of the orchestra has nearly 100 members. For more than 50 years, with the constant effort of Mr. Peng Xiuwen, the famous Chinese conductor and composer, a basic structure for folk orchestra based on the combination of string instruments, plucked instruments, wind instruments and percussion instruments has been formed contributing a lot of the development of folk orchestra. 43 orchestra members will perform in Muscatine. These members plus a small support staff will spend three nights in Muscatine. They will have performed in Chicago and Detroit as part of Chinese New Year Celebrations and then will present a free concert for the community of Muscatine. CBCO Orchestra members wish to experience the hospitality and home stays as their President Xi Jinping did in Muscatine in 1985. Please see the attached info.

Chair Thodos called the meeting to order at 3:34 p.m. He recognized outgoing Commissioners Gluba, Hopkins, Meeker, and Volz, thanking them for their service and presenting them with certificates of appreciation.

1. Approval of the November 18, 2015 Minutes. Ms. Kelly moved to approve the minutes of November 18, 2015 as presented. Mr. Schloemer seconded the motion, and it passed unanimously.
2. Treasurer’s Report. Mayor O’Boyle presented the Treasurer’s Report for the month ending November 30, 2015, noting an ending total bank and book balance of \$552,242.00. Mayor O’Boyle moved the report be accepted as written and mailed. Mr. Sunderbruch seconded the motion, and it passed unanimously.
3. Finance and Personnel Committee.
 - a. Bills. Mr. Austin presented the bills totaling \$90,398.55, as listed on the following bills listing and addendum dated December 16, 2015:

Mr. Austin moved approval of the bills totaling \$90,398.55 as presented above. Ms. Sherwin seconded the motion, and it passed unanimously.

- b. Report on Progress on Commission's FY 2015-16 Program Budget as of November 30, 2015.
Mr. Austin explained the Program Budget Status Report was mailed in members' packets. The Commission is 42% through the fiscal year with 38.7% expended and within budget.
- c. Contracts/Grants for Consideration. Ms. Bulat presented the following contract for consideration.
 - Contract with Center for Community GIS for Phase 2 trail website improvements not to exceed \$14,000 for the period of December 16, 2015 to September 29, 2016.Ms. Kelly moved approval of the contract as presented above, and Mr. Maranda seconded. The motion passed unanimously.
- d. Consideration of Recommendation to Accept the Financial and Compliance Report for the year ended June 30, 2015. Mr. Austin stated the Finance and Personnel Committee received a detailed audit presentation and are recommending approval of the audit report. He reported that Bohnsack and Frommelt stated that Bi-State complied with all laws, regulations, contracts, and grants. The Commission once again received the highest audit opinion, an unmodified opinion "Clean Audit" with no findings or questioned costs.
Mr. Austin made a motion to accept the Finance and Compliance Report for the year ended June 30, 2015. Mr. Maranda seconded the motion, and it passed unanimously.
- e. Consideration to Renew the Executive Director's Annual Employment Agreement. Mr. Austin reported evaluation forms were sent to Commissioners and member government officials, with Ms. Bulat receiving high marks by those who responded. Mr. Austin stated the Finance and Personnel Committee recommended the Executive Director's employment contract be renewed for the year November 1, 2015 – November 1, 2016, with a 1.0% merit increase, along with any budgeted wage adjustment received by all staff across the board.

Mr. Austin made a motion to renew the Executive Director's annual employment agreement with a 1.0% merit increase in addition to any budgeted wage adjustment received by all staff across the board. Mr. Maranda seconded the motion, and it passed unanimously.

4. **Bi-State Region Trails Update.** Ms. Miller reported that Bi-State staff has teamed up with Quad City Health Initiative (QCHI) and other local partners to create a new interactive trails map and website for the Quad Cities Area. Funding for the project is from the Partnerships to Improve Community Health grant through the Centers for Disease Control and Prevention (CDC). It's one of four local efforts focused on improving access to healthy foods and physical activity opportunities. Bi-State staff have been primarily involved in the creation of Safe Routes to School plans, as well as development of the new trails website, QCTrails.org, which is scheduled to go live in late January 2016.

Ms. Miller explained the website's primary goal is to provide a resource showing the 54 trails identified in the Quad Cities Area to-date, in one convenient website. It will also show landmarks, points of interest, infrastructure, and other valuable resources such as parking, water, restrooms, information kiosks, parks, etc. QCTrails.org is also intended to engage users and provide opportunities and incentives for active living by using the marvelous trail resources in the area. QCTrails.org users can create a login area to log their trails, keep track of their progress and accomplishments, and earn online badges when they've completed certain trail activities. In addition, users can share their accomplishments via social media such as Facebook, Twitter, Pinterest, and many more.

A final goal of the entire project is to reach the community through QCHI's Be Healthy QC marketing campaign, including billboards, social media, digital ads, and give-aways such as posters, magnets, water bottles, etc.

Mr. Schmid reported that communities in the Bi-State region are making strides to improve conditions for bicyclists and pedestrians. Iowa Trees Forever is working with local leaders in Muscatine to draft the Running Rivers Trail Vision for the city with proposed enhancements that may be included in the Riverfront Master Plan Update. The city will be extending the Mississippi River Trail (MRT) to the Louisa County line to the south as early as next year, and will be including signage for the MRT and American Discovery Trail (ADT). Bi-State staff is coordinating efforts with colleagues between the Quad Cities and Cedar Falls/Waterloo to connect gaps in the route of the ADT, which is a national trail running from Delaware to California that crosses the Mississippi River at Davenport. The City of Geneseo, also, is interested in connecting the city to the Hennepin Canal State Trail. The Illinois Department of Natural Resources maintains the Hennepin Canal Trail and is planning on investing over \$1 million in maintenance projects along the trail in coming years.

In the urbanized Quad Cities, the Iowa MRT is being extended at both ends. The City of Buffalo will begin construction in 2016 to extend the national trail from the Davenport border to County Road Y-40, nearly to the Muscatine County line. The trail's eastern terminus was extended in 2015 in Riverdale from Bellingham Street to Fenno Road along U.S. 67. Bettendorf plans to extend the trail from there to its eastern city limit, where cyclists may use paved shoulders to ride to LeClaire. Princeton has also begun to pull funds together to construct a trail through town to connect to the Princeton Wildlife Management Area. Davenport added to its inventory of bicycle lanes in the city, notably on Jersey Ridge Road, and next year will see further Complete Street additions. Eldridge is one step closer to realizing a long-sought-after goal of building a trail south of town to connect to Davenport and Bettendorf trail systems. The city is in discussions with the Canadian Pacific Railway to acquire about one mile of right-of-way along tracks running south adjacent to First Street. Moline has also begun development on its River-to-River Corridor, roughly from SouthPark Mall to downtown and the new I-

74 Bridge trail crossing. The development of this corridor is a long-term effort that requires coordination with the Illinois DOT along numerous sections.

Mr. Schmid concluded by noting Bi-State staff drafted two long range transportation plans (LRTP) in 2015, one for the urban area (MPA) and one for Iowa Region 9, comprised of rural Scott County and all of Muscatine County. The LRTPs identified approximately 300 miles of various bicycle improvements in the urban Quad Cities, and 43-184 miles of proposed trails in Region 9. Input for these plans was received from the public, the Bi-State Regional Trail Committee, and the Transportation Technical Committee. To aid in the planning efforts, Bi-State staff runs a trail counter program to collect data on trail use in the Bi-State region. Counters have been loaned out to six cities in the region, with some locations having over 400 days' worth of data. Most locations count an average of about 100 to 300 users daily throughout the year.


Mr. Grimes announced that Bettendorf City Council was presented with a Bronze Level Award as a Bicycle Friendly Community by the League of American Bicyclists in November. The award recognizes communities that welcome cyclists by providing safe accommodations for cycling and encouragement for people to cycle for transportation as well as recreation. Bettendorf became the sixth community in Iowa to be awarded Bicycle Friendly Community (BFC) status. The BFC program is centered on the “Five E’s”: engineering, education, enforcement, evaluation, and encouragement. Communities must show their commitment to these five areas of importance for the bicycling public in order to be considered a Bicycle Friendly Community. The City of Bettendorf had applied previously in spring 2014 and received an honorable mention, which highlighted the city’s strengths and weaknesses as a cycling community. That designation was upgraded due to the enhancements to cycling in Bettendorf since then. Formed as a result of the initial BFC application, the Bettendorf Bicycle and Pedestrian Advisory Committee (BBPAC) was created to further the goals of being a BFC and to highlight areas of improvement that are important to the cycling and pedestrian community. Also as a result of the initial BFC application, the city hired the Quad Cities’ first city-staffed Bicycle and Pedestrian Coordinator.

5. Consideration of Letter of Support for Mississippi River Cities and Towns Initiative. Ms. Bulat presented a letter of support for the Mississippi River Cities and Towns and Initiative annual meeting to be held in the Quad Cities in 2018.

Mr. Schloemer moved approval of letter of support as presented above, and Ms. Callaway-Thompson seconded. The motion passed unanimously.

6. Questions or Comments by Commissioners. There were no questions or comments by Commissioners.
7. Other Business. There was no other business.
8. Adjournment. The meeting adjourned at 4:30 p.m.


