### **CITY OF MUSCATINE RECEIVES CLEAN AUDIT REPORT**

*Unmodified audit opinion of fiscal year 2018-19 released by City of Muscatine*

**MUSCATINE, Iowa** - The City of Muscatine has once again received an unmodified (“clean”) opinion according to the annual audit report for the fiscal year ending June 30, 2019, performed by Bohnsack and Frommelt LLP, certified public accountants, earlier this year.

Nancy Lueck, Finance Director, reported to the Audit Committee of the Muscatine City Council, that the audit opinion also noted that there were no findings again this year on the single audit (federal grant) component of the audit. She also noted that no deficiencies in internal control or material weaknesses were noted during the audit.

Lueck has been with the Finance Department since 1977 and has served as its director since 2005.

The City released the report following a presentation to the Muscatine City Council on Thursday, Dec. 5.

The City’s revenues totaled \$47,663,094 for the year, a decrease of \$1,103,951 from the prior year. Revenues included \$15,941,284 in property taxes, \$4,129,573 of other taxes, \$17,430,933

of charges for services, \$7,301,608 of operating grants and contributions, \$1,392,286 of capital grants and contributions, and \$1,467,410 of other revenues.

Expenses for City operations for the year totaled \$44,444,906, a decrease of \$571,473 from the prior year. Expenses included \$28,457,780 for governmental activities and \$15,987,126 for business-type activities.

The Comprehensive Annual Financial Report (CFAR) will be submitted to the Government Finance Officers Association (GFOA) for consideration of the Certificate of Achievement in Excellence in Financial Report. The City of Muscatine has received the award for 25 consecutive years. The GFOA is a nonprofit professional organization serving approximately 17,500 government finance professionals with offices in Chicago, IL, and Washington, D.C.
