## City Administrator Report to Mayor & City Council

July 5 & 12, 2013, Edition No. 93

### REPORT:

1. **MMGC:** Please see the attached information on the golf course rounds year-to-date.
2. **Fire Engine:** For your information a copy of the fire engine design is attached. The engine is schedule for pick up on July 25 with arrival in Muscatine on the 26th.
3. **Fire Station #2 Update:** We have heard that the General Contractor is going out of business. We have not heard anything formal from the contractor. We have a few minor items remaining to be corrected in addition to staining and a final resolution on the concrete panels. We are working with our attorney to come to a final resolution.
4. **ATE:** Attached is the ATE summary report in the new format updated for June tickets issued/paid. This should be the final report for FY 13.
5. **Budget:** The FY 2013/2014 Budget is done and now on the website! We have a very limited number of printed copies - generally one per department and a few extras if anyone wants one. Please contact Fran or Nancy if you prefer a paper copy over the web-based version.
6. **CVB:** Please check out the CVB's new website at the following web address - <http://www.visitmuscadine.com>
7. **Grate:** As discussed during budget, please see the sample tree grate (flower bed/tree bed) we are planning to use at the intersection of 2nd Street and Sycamore (Adjacent to the Chiropractic Office). We are planning to use this recycled plastic grate in lieu of bark and to improve maintenance time and costs.
8. **MDA:** The Fire Union is once again looking to hold a boot drive in support of MDA. The Mayor and I have met with Union representatives and reminded them that last year was to be the last year the event was to be held in the streets. The boot drive presents safety issues and is no different than panhandling. City staff can not be expected to enforce panhandling (where possible) at the same time we allow boot drives in the street. We have discussed numerous alternatives over the past few years. The union has failed to come up with alternate plans this past year and they are now looking to fall back on the traditional boot drive. I will be meeting with the union at the Fire Station next Tuesday evening. The fire union is holding a meeting at the Fire Station next Wednesday night to review their MDA accomplishments. The Union may not lobby at the station in support of a boot drive. Pending the outcome of next week's meeting the union may attend the Council meeting on the 18th during the public speaking portion of the meeting to make a request of Council. Hopefully between now and then an alternative will be considered.
9. **Comp Plan:** Below are links to the current DRAFT of the Comprehensive Plan. The plan has been through Planning Commission review and will now be brought forward to the City Council in late August or at the September In-Depth. This


