City Administrator Report to Mayor & City Council

December 20, 2013, Edition No. 110

REPORT:

1. Chamber: Please see the attached letter from GMCCI regarding the upcoming Annual Dinner.
2. CIP: The CIP will be distributed at the January 9th In-Depth Session. On a related note, I was asked to pass on objections from a former Cemetery Commission member regarding the cemetery Steps and his preference that the steps not be replaced due to the high incidence of vandalism that occurred within the cemetery when the steps were open to the public.
3. Police Department: "Shop with a Cop" We ended up taking 102 children shopping with our Shop with a Cop program. We spent nearly \$10,000 from donated funds through the Muscatine Police Association. The association receives donations from many businesses and private donations though out the year. With these donations numerous children have had the opportunity to experience a Merry Christmas. Without this program many of these children would not have a Christmas.
4. ATE: (REMINDER) Per GATSO - "Just so we are all on the same page, the next step will be for "final notice" to be put forward to the Governor's office for approval and will then be eligible for review by the Administrative Rules Review Committee (ARRC). I have provided a link to the members of this committee for your information below. We have provided some contact information of these members to some of our client cities. This allowed each city to voice individual thoughts and concerns. The more these committee members hear from the communities that take part in these programs the better. They need to understand exactly what is at stake and how communities will be affected. Please feel free to reach out and share your thoughts. Although the next meeting for the ARRC is in January, we've communicated with the Chair of this committee and learned this item will be on the agenda for the February meeting. This will buy us some additional needed time to pursue some legislative options. The actual date in February is not known yet and will be announced the end of January. 5. Recycling: The single-sort recycling program is in its third year and has continued to have a success rate of 95% of our residents participating in the program. The single-sort program has allowed for recycling at the most convenient way possible, in one container, and at the curb. Muscatine residents in the past fiscal year recycled 1,330 tons of recycling. The contract with Allied Waste for the first five years expires in April 2016. There are five, one-year renewal clauses in the contract.
6. Compost Site: The Compost Site is another program that is has a high usage rate from our residents. Over the past two years, the City of Muscatine has had a contract with Country Stone to grind wood debris and screen compost. The excess amount that is not needed on our site is removed and taken to Country Stone's plant in Moline, IL to be mixed and sold in landscaping products. The contract has no monetary exchange between the organizations, but it does save the City \$20,000.00-\$30,000.00 a year in grinding cost.
