To Whom it may concern,

We received a call from Brett Talkington that there is a conflict with our original requested route for our annual Corpus Christi Procession for St. Mary Mathias Catholic Church. The only other route we can possibly suggest that would accommodate our needs is as follows.

Crossing Pine St. (out from our parking lot) we would proceed through our vacant lot and onto Fuller Street. We would proceed up Van Horne to Roscoe St. and turn right.
