A RESOLUTION CONVEYING VACATED RIGHT-OF-WAY (A PORTION OF BRIER STREET) IN THE CITY OF MUSCATINE, IOWA TO THOMAS M. MCCLEARY SR. AND THOMAS M. CLEARY JR

WHEREAS, the Planning and Zoning Commission of the City of Muscatine has recommended approval of the vacation and conveyance of the Brier Street right of way and a portion of an adjoining alley right of way to the adjoining property owners and; and

WHEREAS, due notice of said proposal to vacate and convey said right-of-way and to further convey said vacated right to the adjoining property owners was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council of the City of Muscatine, Iowa at public hearing held on September 19, 2019; and

WHEREAS, the said right-of-way was vacated by Ordinance, on October 18, 2019; and

WHEREAS, Thomas M. McCleary Sr. and Thomas M. Cleary Jr. are the adjoining property for the portion said vacated right of way identified in the Right of Way Vacation Plat attached hereto as Exhibit A and is described as follows:

THE NORTHEASTERLY HALF OF BRIER STREET ADJACENT TO LOT 1 IN BLOCK 7 OF GEORGE SMALLEY'S ADDITION TO SOUTH MUSCATINE, IN THE CITY OF MUSCATINE, MUSCATINE COUNTY, IOWA; CONTAINING 4,800 SQUARE FEET OR 0.110 ACRES.

WHEREAS, it the intent of the City to convey said vacated right of way Thomas M. McCleary Sr. and Thomas M. Cleary Jr.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE, IOWA, as follows:

1. The City of Muscatine, Iowa, will sell and convey its rights, title, and interest in and to the real property described in the copy of the deed attached to this Resolution marked Exhibit B to Thomas M. McCleary Sr. and Thomas M. Cleary Jr. for \$10.00, the receipt of which is hereto acknowledged.
2. The deed will be in the name of the City of Muscatine, Iowa; will be signed by the Mayor and attested by the City Clerk; and will be in substantially the same form as the copy of the deed attached as Exhibit B to this Resolution.
3. Any Resolution or part thereof in conflict or inconsistent with this Resolution is repealed.


