

A. Resolution Approving the Plans, Specifications, Form of Contract, and Cost Estimate for the Grandview Avenue Reconstruction Project

Presented for City Council's consideration is a resolution approving the plans, specifications, form of contract and cost estimate for the Grandview Avenue Reconstruction Project. (Public Hearing A)

B. Resolution Setting a Public Hearing on Proposed Zoning Changes – Grandview Senior Lofts

Presented for City Council's consideration is a Resolution setting a public hearing for February 6, 2020 at 7:00 p.m. regarding the Zoning Changes for Grandview Senior Lofts. The Planning and Zoning Commission of the City of Muscatine has been requested to rezone 7.59 acres located on the north side of Grandview Avenue from M-1 Light Industrial and R-2 Single Family Residential to R-6 Multi-Family Residential. The applicant has requested this to enable the construction of a 51-unit multi-family dwelling for low and moderate-income seniors.

C. Resolution Setting a Public Hearing on Proposed Zoning Changes – Colorado Senior Lofts

Presented for City Council’s consideration is a Resolution setting a public hearing for February 6, 2020 at 7:00 p.m. regarding the Zoning Changes for Colorado Senior Lofts. The Planning and Zoning Commission of the City of Muscatine has been requested to rezone 4.56 acres located at 400 Colorado Street from M-3 Multi Family Residential to R-6 Multi-Family Residential. The applicant has also concurrently requested the voluntary annexation to enable the construction of a 51-unit multi-family dwelling for low and moderate-income seniors.

D. Resolution Approving the Final Plat of Stanley Woods Addition

Presented for City Council’s consideration is a Resolution approving the final plat of Stanley Woods Addition. The New Hope Foundation submitted a preliminary/final plat for a one lot subdivision located at 114 Sunset Drive. This subdivision will create a new 4.26-acre parcel containing the existing residence at 115 Sunset Drive. The intent of subdivision is to facilitate the sale of the existing home. Said plat has been approved by the Planning and Zoning Commission and fully conforms with the City of Muscatine Ordinances.

E. Resolution Authorizing the Assessment of Unpaid Nuisance Abatement Costs to Private Properties

Presented for City Council’s consideration is a resolution authorizing the assessment of unpaid abatement costs to private properties. The nuisance abatement costs total \$2273.38, the administrative fees are \$1025.00, and the assessments fees are \$1050.00. The total fees being requested for assessment at this time total \$4348.38.

F. Resolution to Implement Fees to Saw Cutting City Streets

Presented for City Council’s consideration is a resolution adopting the implementation of fees for saw-cutting City Streets. Effective March 1, 2020, the City of Muscatine will require all saw cuts for pavement removal to be cut to full depth of existing pavements. In the past the City crews have performed these cuts on a will-call basis for no charge. This practice is no longer sustainable and a fee schedule has been created to allow City staff to continue to perform the work if requested, and to allow the City to recover the costs of the operations.

Presented for City Council's consideration is a request to approve the renewal of an interagency agreement between the Iowa Department of Inspections and Appeals and the Muscatine Municipal Housing Agency.

Presented for City Council's consideration is a Request to approve a Professional Services Agreement with Stanley Consultants for the High Strength Waste Digester Rehabilitation Project. This project is designed to create additional digester capacity at the treatment plant. Stanley Consultants has submitted a proposed agreement not to exceed \$135,000.00. There is \$150,000 budgeted for this service.
