The County Assessor shall make a physical review of all properties with approved applications. <b>The County Assessor shall determine the increase in actual value for tax purposes due to the improvements and notify the applicant of the determination,</b> which may be appealed to the local board of review pursuant to Section 441.37 of the Code of Iowa. After the initial tax exemption is granted, the County Assessor shall continue to grant the tax exemption for the time period specified on the approved application. The tax exemptions for the succeeding years shall be granted without the owner(s) having to file an application for succeeding years.
