 RE: Approval of Golf Course Non-Alcohol Beverage Agreement

INTRODUCTION:

Please accept this memo and the attached information as a request for the Muscatine City Council to approve the proposed Golf Course exclusive Non-Alcohol Beverage sales agreement.

BACKGROUND:

The current non-alcohol beverage five (5) year agreement at the Muscatine Municipal Golf Course expires on February 28, 2013. The agreement included pop, sports drinks, bottled water, and other non-alcohol related drinks for exclusive sales rights.

In December 2012 the attached request for proposal form was sent to perspective vendors that could meet the needs of the community as detailed in the solicitation.

Two vendors responded to the Request for Proposal and they are as follows:

<u>Vendor</u>	<u>Rank</u>	<u>Cost Factor</u>
Coca Cola Refreshments	1	\$12,466.88
Sprouse Distributing Inc.	2	\$15,844.75

The "Cost Factor" is based on the attached "Beverage Vendor Comparison" sheet that was prepared by Dan McGinn, City of Muscatine Golf Professional. The information in the comparison was taken from the vendor submittals which was part of the Request for Proposal which included product cost and annual incentives. The "Cost Factor" demonstrates that the Coca Cola Refreshments Proposal is projected to cost \$3,377.87 less annually and \$16,889.35 less over the five (5) year proposed agreement period. The projections are based off of the latest sales history and assumes a like sales future.

RECOMMENDATION/RATIONALE:

At this time, City Staff would recommend that the Muscatine City Council approve a five (5) year agreement with Coca Cola Refreshments for the provision of exclusive non-alcohol beverages at the Muscatine Municipal Golf Course.

Reference checks were performed with positive results achieved. The City Staff and City Attorney have reviewed this recommendation and the requirements of the Request for Proposal. Market share was not considered as it represents future sales speculation and not financial guarantees as it relates to an exclusive sales program.

After assessing the two proposals returned for the golf beverage supplier request for proposal it is my recommendation that we enter into a five year contract with Coca Cola Refreshments. Coca Cola Refreshments is offering a \$2,000 incentive for being the exclusive beverage provider at the Municipal Golf Course and they are willing and able to meet the other requirements in the scope of services in the RFP. I have attached a beverage vendor comparison sheet that applies the proposed unit pricing to previous year's sales under the assumption that sales with Coca Cola would be the same as Pepsi's actual sales during that time. This document shows a yearly difference of approximately \$3,400 when comparing the pricing and the incentive proposed by each vendor.

Summary: The City of Muscatine is seeking a multi-year arrangement for the provision of non-alcoholic beverages at the Muscatine Municipal Golf Course. We are soliciting for a dependable and professional vendor to provide this service. The following minimum standards should be taken into consideration as you prepare your proposal.

1. Provide a complete product list that your firm will be able to supply. Please include unit size, case size and seasonal availability if applicable.
2. Provide a complete and detailed product price list.
3. Provide a complete and detailed product retail price recommendation by individual unit.
4. Provide the delivery schedule for year round delivery.
5. A minimum of one (1) vending machine for outside locations is requested.
6. Selected vendor must obtain all necessary licenses and permits if applicable.
7. Selected vendor is expected to provide regular and emergency customer service within 24 hours of notification
8. Selected vendor must have current beverage supply experience.
9. Selected vendor is expected to provide acceptable references.
10. Selected vendor will enter into a contract with The City of Muscatine.
11. Selected vendor will be required to provide acceptable and standard for the trade insurance coverage as requested.
12. The following equipment shall be provided by the selected vendor and at the vendor's expense throughout the term of the agreement. These coolers requirements should be considered minimum. Additional coolers may be requested throughout the contract term:
 - a. Two (2) coolers with dimensions of 24" width, 24" depth and 60" height capable of cooling 6 cases of 20 ounce bottles.
 - b. One (1) cooler with dimensions of 51" width, 24" depth and 78" height capable of cooling 20 cases of 20 ounce bottles with two (2) sliding doors.

- c. One (1) cooler with dimensions of 36" width, 24" depth and 58" height capable of cooling 9 cases of 20 ounce bottles with two (2) doors.
- d. One (1) fountain pop dispenser with six (6) heads and ice chest not to exceed 25" width 27" depth and 60" height.

The selected vendor should expect the supplied cooler to be used as needed by the golf course concession operations. This will included refrigerated food needs and alcohol related beverage cooler needs.
