MUSCATINE COUNCIL TO SET TWO PUBLIC HEARINGS

South End Project, Utility Franchise Fee reduction hearings to be scheduled

MUSCATINE, Iowa – The Muscatine City Council will set a date for a public hearing on the South End Playground Development Project and a public hearing on a decrease in the utility franchise fee when the council convenes Thursday (December 2) in the Council Chambers of Muscatine City Hall.



A virtual meeting will be held in conjunction with the in-person meeting for those who want to view the proceedings or make a comment but do not feel comfortable in attending in person. Details for joining that meeting are listed below.

The City of Muscatine Parks and Recreation Department has developed the plans and specifications for the South End Playground Development Project that is part of the South End Community Improvement Fund Projects. A public hearing must be held prior to the approval of the plans and specifications, and Rich Klimes, Parks and Recreation Director, is asking the Council to set the Public Hearing for 7 p.m. on December 16, 2021.

The improvement projects were developed in collaboration with the steering committee to make recreational improvements in the south end portion of the Muscatine community. The project will be funded through a \$2 million private donation to the City.

Following a discussion of the Utility Franchise Fee at the November 18 meeting, a consensus was found among Council members to decrease the Utility Franchise Fee from its current five percent rate to three percent effective on Feb. 1, 2022. A public hearing is required to begin the process since the change requires an amendment to the Utility Franchise Fee ordinance. Nancy Lueck, Finance Director, is asking the Council to set the Public Hearing for 7 p.m. on December 9. The first reading of the ordinance amending the franchise fee rate will be held following the public hearing.

The decrease in the franchise fee requires three readings of the amended ordinance, approval and publication of the ordinance change following the third reading, and approval through Alliant Energy and the State of Iowa. Lueck believes that the reeducation can be accomplished before the February bills are sent out if no problems are discovered with the ordinance change, Alliant Energy, or the State of Iowa regulatory board.

Thursday's City Council meeting is open to the public. Citizens attending the meeting are asked to follow current CDC (Centers for Disease Control) recommendations for wearing a mask indoors whether vaccinated or not. The City of Muscatine does not require wearing a mask, but does urge the public to follow Public Health and CDC recommendations.

Citizens who do not want to attend the in-person meeting can watch and/or participate through the GoToMeeting virtual meeting portal. Information on joining the session and how to make a comment during the meeting is listed below. The session will also be broadcast live on the City of Muscatine [YouTube channel](#) and on Muscatine Power & Water Cable Channel 2.
