Historic Preservation Commission

The Historic Preservation Commission helps protect Muscatine's historic, cultural, and architectural character. Members work to preserve significant sites and districts and ensure the city's historic assets are maintained for future generations.

Zoning Board of Adjustment (ZBA)

The Zoning Board of Adjustment is a quasi-judicial citizen board responsible for interpreting zoning ordinances. Its duties include granting variances for unique hardships, approving special exceptions or conditional uses, and hearing appeals of planning staff decisions. The board plays a key role in ensuring fairness and flexibility in local development.

- **Meeting schedule:** 5:30 p.m. on the first Thursday of each month in the City Council chambers at Muscatine City Hall
- **Term length:** Five years, with a limit of two consecutive terms
