Below is the email we spoke of on the phone as well as pictures of the fallen brush. Thank you for your assistance in trying to accommodate this request. Please let me know if you need any further information.

To Whom it May Concern:

I would like to request acreage between myself and my neighbor, Eric Wagner, be combined for the purposes of a burn permit. Both of our individual lots are almost an acre, but not quite, and due to the acreage requirements neither of us are able to purchase a burn permit. Approximately 80% of both lots are wooded area, however due to the tornado of 2010 that went over our lots there are large masses of fallen tree. I was advised that the cost to have these removed from the raven would be quite expensive and labor intensive. Thus my request for a burn permit so Eric and I can burn the deadfall at our convenience with little to no cost to Eric and myself or the City of Muscatine. I've attached photos for your review, hopefully in viewing these you will get an understanding of how much deadfall is currently on our properties as a result of the tornado. Safety of course is of the utmost importance to us and therefore we've completely cleared an area of brush should this permit be allowed. We'd welcome a visit to ensure all safety precautions will be taken.
