### INTRODUCTION:

The City of Muscatine Public Works Department compiled a list of alleys to be asphalt overlaid this current fiscal year (FY 2019/20). Bids were received on June 20, 2019.

### BACKGROUND:

On July 18, 2019 – City Council voted to approve the resolution awarding the 2019 Asphalt Alley Program to Taylor Ridge Paving of Andalusia, Illinois. On August 1, 2019, City Council voted to not approve the resolution to approve contract and bond for this work. Therefore, a resolution to rescind the award of contract is needed so that all bids can be rejected.

City staff requests the adoption of a resolution to rescind the resolution to award and to reject all bids for the 2019 Asphalt Alley Program.
