Staff has been reviewing the current uniform program and requested new bids for the upcoming fiscal year.

Bids to provide uniform items were sought and two responses were received. CCP Industries provided the low bid and is able to provide all of the requested clothing items. The low bid was determined by applying the bid prices to last year's order. CCP Industries total bid ordering the same items as last year would be \$15,504 and the total bid for Aramark would have equaled \$16,831. The City spent approximately \$24,000 on uniform items last year.

At this time, I am requesting City Council's approval to approve a three year contract with CCP. If you have any questions or require additional information, please let me know.

CONTRACT FOR PURCHASED UNIFORMS

WHEREAS, the contract for purchased uniforms will be in effect from July 1, 2012 to June 30, 2015.

WHEREAS, there will be no price increase during this contract.

WHEREAS, termination of this contract may be done by either party. A thirty (30) day notice is required if the contract is terminated.

Purchased Uniform Items

WHEREAS, the Vendor will provide the following clothing options in agreed upon colors, styles, and brands as follows:

1. Crew neck sweatshirt
2. Hooded Pullover Sweatshirt
3. Zip Up Hooded Sweatshirt
4. Baseball style jacket
5. Polo Shirt
6. Tee Shirt DOT Class II Reflective Tee Shirt
7. Short sleeve Tee shirt
8. Jeans in straight and carpenter styles
9. Blue pants in cargo style
10. Blue shorts available in straight and cargo styles

The parties agree that this Agreement is the complete expression of the terms hereto and any oral representations or understandings not incorporated herein are excluded. Further, any modification of this agreement shall be in writing and signed by both parties. Failure to comply with any of the provisions stated herein shall constitute material breach of contract and cause for termination.
