INTRODUCTION:

Annually the City of Muscatine has an Asphalt Overlay Program. The City allocated \$250,000 in the FY 13/14 budget for this work.

BACKGROUND:

The City took bids in August and awarded a contract to Brandt Construction Co from Milan, Illinois in the amount of \$192,204.00. Overlay work to be performed included Island Road, Island Court, McIntire Road, #2 alley between Cherry and Ash Streets, and the parking area at Weed Park.

RECOMMENDATION/RATIONALE:

The 2013 Asphalt Overlay Program for the City has been completed and staff recommends accepting the work. One Change Order in the amount of \$500 was issued for additional work on Dick Drake Way for a total project cost of \$192,704.00. The balance of the \$250,000 will be used as the city's portion of the overlay work the State of Iowa is doing on Washington Street from Park Ave. to the Corporate limits.

**RESOLUTION ACCEPTING COMPLETED WORK PERFORMED UNDER
THE 2013 ASPHALT OVERLAY PROGRAM
AND AUTHORIZING FINAL PAYMENT**

WHEREAS, the City of Muscatine approved the Plans, Specifications, and Form of Contract for the 2013 Asphalt Overlay Program; and

WHEREAS, the City of Muscatine entered into a contract for said project with Brandt Construction Company for \$192,204 with change orders totaling \$500, for a total contract amount of \$192,704; and

WHEREAS, all work under the contract has been completed by Brandt Construction Company and approved and accepted by the City Engineer and appears to meet the requirements of the Plans and Specifications heretofore adopted by this Council, as evidenced by the Project Engineer's Certificate; and

WHEREAS, a balance of \$192,704 including 5% retainage remains due and payable;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE, that the City of Muscatine make immediate payment of \$183,068.80 to Brandt Construction Company for completed and accepted work under the 2013 Asphalt Overlay Program Project and thereafter make an additional payment of \$9,635.20 which represents the 5% retainage thirty (30) days from the date of this acceptance.
